#### COURSE OBJECTIVES:

Upon completion of the course, the student will be able to:

1. Utilize the scientific principles of pathophysiology, pharmacokinetics and pharmacotherapeutics in the assessment and management of health and acute or episodic illness in individuals and families across the adult/older adult age spectrum.
2. Implement health screenings, health promotion activities, and a plan of care for individuals/families based on clinical practice guidelines, current research, and individualized patient/family needs.
3. Utilize advanced health assessment skills to perform appropriate comprehensive or focused exams, differentiating normal from abnormal based on age, gender, ethnicity, and health status.
4. Incorporate information from the health history, physical examination, diagnostic tests, developmental status, and family needs to formulate a data base, identify differential diagnoses, and establish priorities of care.
5. Establish health outcomes based on re-evaluation of the data base and changes in health status.
6. Develop a collaborative relationship with individuals and families to implement a comprehensive and dynamic plan of care to maximize physical and mental health and treat acute/episodic illness.
7. Develop therapeutic interventions related to social, cultural, spiritual, bioethical, and economic factors affecting the health care needs of individuals, families, and underserved populations.
8. Collaborate with other health professionals to deliver evidence-based, safe, and cost-efficient health care in and across care settings.
9. Maintain standards of professional behavior and accountability in the implementation of the Nurse Practitioner role.
10. Implement the roles of the Nurse Practitioner in advanced practice.
