#### **COURSE OBJECTIVES**

Upon completion of the course, the student will be able to:

- 1. Apply knowledge of nursing theory and the scientific principles of pathophysiology, pharmacokinetics and pharmotherapeutics in the assessment and management of chronic and/or complex health problems in individuals and families across the life span.
- 2. Implement health screenings, health promotion activities, and a plan of care for individuals/families based on clinical practice guidelines, current research, and individualized patient/family needs.
- 3. Perform a pertinent comprehensive or focused physical exam, differentiating normal from abnormal considering age, gender, ethnicity, and health status.
- 4. Synthesize information from the health history, physical examination, diagnostic tests, developmental status, and individual/family needs to formulate a data base, identify differential diagnoses, and establish priorities of care.
- 5. Develop individualized health outcomes based on information from the data base and changes in health status.
- 6. Establish a collaborative relationship with individuals and families to implement a comprehensive and dynamic plan of care to maximize physical and mental health and treat complex and/or chronic illness.
- 7. Incorporate age, gender, health status, social, spiritual, cultural, genetic, occupation, financial, and lifestyle factors in the assessment and treatment of individuals, families, and underserved populations with chronic/complex health problems.
- 8. Collaborate with other health care professionals to deliver evidence- based, safe, and cost efficient health care in and across care settings.
- 9. Apply the role of the Nurse Practitioner in and across care settings.
- 10. Integrate standards of professional behavior and accountability in the implementation of the Nurse Practitioner role.
